Agenda Item IV. Old Business

<u>Transportation</u> – Open discussion. Kelly reported that she contacted TILRC regarding the survey information completed at the public forum several months ago. She was informed that the results have not been gathered and probably wouldn't be. Mitzie reported she had talked with Mary Ann about the Big Tent Coalition. It may be possible for a Council member to attend a meeting if interested. The Big Tent Coalition is a service provider organization based group addressing disability concerns statewide. It was discussed that additional cuts to the Lift service and bus route schedules has been planned due to lack of funds. Linda commented that there is a possibility that the bus will run every hour vs. half hour and the evening/Sunday Lift service may be eliminated. Barbara talked about her concerns with relying on staff for transportation. It has been suggested that members contact the City Council about the need for public transportation. Anna Marie suggests asking Council representatives about how to present concerns during a City Council meeting. Cindy shared that she has been actively involved with writing letters, etc. and if funds are not available it will be a challenge. The funds had been approved in July and now being withdrawn. It was discussed that City Council members may benefit from a sensitivity training to experience what people who rely on public transportation encounter daily.

Kelly makes a motion for the CDDO to coordinate a transportation work group with affiliated provider participation. Mitzie seconds and motion carries. Cindy volunteers to participate on this work group and is available to meet most Tuesday & Wednesday mornings.

Agenda Item VI. CDDO Report - Ramona Macek

Ramona reports on the number of adults and children receiving services in Shawnee County, 767 adults and 268 children. There have been 6 crisis requests reviewed by the CDDO Funding Committee as of July 1, 2010. 3 met the crisis language criteria and approved; 3 did not so were denied. Twenty-four persons have come off the statewide waiting list for Shawnee County.

The CDDO collaborated with KNI to host an Open House on September 24th. KNI & PSH sent invitations to guardians of individuals living at KNI and PSH to learn more about community services available in Shawnee County. The Open House was held at KNI and fourteen affiliated providers participated.
