The CDDO statistical report was reviewed. There are 1054 adults and children receiving services in Shawnee County. There were 5 people who were crisis approved in July. There is one new affiliated provider; ANS Living. ANS Living is affiliated to provide day and residential services. RRG Life Services affiliate agreement was terminated July 31, 2012 and & Family Living Inc. affiliate agreement terminated August 24. Both agencies provided day and residential services. Total number of affiliates is 66.

The legislators approved FY2013 funds for the HCBS DD waiver waiting list so the State of Kansas will be notifying CDDOs if there are people to be offered services in their area. If people residing in Shawnee County are identified from the statewide list, the person/responsible party and case manager will be notified by the CDDO Funding Coordinator.
