TAKE ME HOME Program

TAKE ME HOME was developed by the Pensacola, FL Police Department for people who may need special assistance during an emergency. This kind of assistance may be required for people:

- unable to speak
- properly identify themselves
- become disorientated
- act in a manner that could be misinterpreted by first responders.

The system includes a current digital picture, demographic information and caregiver contacts.

If a person enrolled in the TAKE

ME HOME program is

encountered by law
enforcement, the officer can
query an internal data base by
searching by the name or by the
person's physical description.

Once the individual's **TAKE ME**HOME record has been located,
the officer has the information
available to assist the person.



How Does the Program Work?

Families or individuals may contact the Topeka Police Department and submit a TAKE ME HOME form containing a recent digital photo, height, weight, and other demographic information as well as emergency contact information.

This information is placed in a database that can be quickly accessed in a law enforcement vehicle or at the Law Enforcement Center. If officers find someone who is unable to communicate where he or she lives, they can search the database by description and return the person to their loved ones. The system also works in reverse: of a loved one goes missing, their picture and description is immediately available.

TAKE ME HOME is voluntary for citizens to participate and all information is kept confidential. There is **no charge** to the agencies for the program and there is **no**

enrollment fee.

Enrollers are asked to keep the information on file updated and current, including a new digital photo of the person enrolled take periodically.

Who may enroll in the **TAKE**ME HOME program?

Any adult OR child who may have difficulty communicating due to a developmental or cognitive disability. These individuals tend to be at risk for wandering and may include people with Alzheimer's, Autism, Dementia, Down Syndrome, etc.

Anyone enrolling an individual is to be a family member, legal guardian or is turning in a signed enrollment form on the behalf of the individual's family with their permission

Individuals who do NOT qualify for enrollment include people with ONLY physical disabilities, hearing or visual impairment, anyone who is able to communicate via translator/interpreter and children who have not reached developmentally appropriate age for speech.

What is needed at enrollment time?

Contact information: address, names and phone umbers of at least (3) emergency contacts.

Information about the person being enrolled (date of birth, hair/eye color, height, weight, disability, what school they attend, medication information and any other information that would assist when having contact with the individual.

The individual being enrolled **needs to be present** at enrollment so a current digital
photo may be taken.
